Regular Delivery

“Super Rush” Delivery

Date of postmark or pickup shall be on or before 4 days after the specified date of the selected wedding video service with an additional charge of \$250.00.

Terms & Conditions

A non-refundable up-front payment of \$200.00 is payable upon *QFM's* arrival at event, prior to video recording. The balance is due within one week following the wedding date and/or before the finished product is delivered. Payment may be made in cash or by personal check. Checks should be made payable to *Matt Yamashita DBA Quazifilms Media*.

In the event that more than one client wishes to book wedding services on the same day, preference will go to the first client to return a signed contract. Rescheduled weddings will only be accommodated if the new date does not conflict with another booked wedding.

QFM will be the exclusive professional videographer. Friends and family are permitted to operate video cameras on the condition that they do not interfere with or get in the way of the professional coverage. It is the client's responsibility to see that this is enforced.

It is the client's responsibility to secure access to areas for videography. *QFM* will not be responsible for coverage lost due to access restrictions.

Creative aspects such as shooting and editing style are at the discretion of *QFM*. Raw video footage is retained by *QFM* for no longer than two (2) months following the event date. *QFM* reserves the right to use the original tape, excerpts and/or reproductions for display or promotional purposes.

QFM will not be held liable for any production problems beyond our control, e.g. bad weather, accidents, poor acoustics/lighting, interference from guests, equipment failure, etc.

QFM reserves the right to terminate this contract at any time for any reasonable cause, e.g. accident or ill health. In this event all monies paid will be refunded in full.

QFM exercises the utmost care with respect to the video services and products offered. Any liability on the part of *QFM* is limited to the amount of monies paid.

Upon taking possession of the finished product, the client must inform *QFM* of any technical or other problems with the video within 7 days. After 7 days, if no notification has been received, the client will be deemed to be satisfied with the product.
